The sluice pipe on Robin Hill Rd has been replaced with a smaller pipe due to the large rock in the road. The water is now flowing through it like it should.

We are still waiting for one more bill from Fox & Son for the clean-up but it is looking like we broke even. We are still looking for a used fridge for the garage but aren't having much luck.

Supervisor Jeffrey Carlstrom made a motion to purchase a sign bracket that is needed Supervisor Kelly VanCise seconded the motion. Motion carried with three votes. The supervisors discussed the replacement of the road signs that are constantly being stolen. Supervisor Matt Wallin made a motion that if a resident wants the road sign replaced then they can pay for the road sign to be ordered and the road crew will install them Supervisor Kelly VanCise seconded the motion. Motion carried with three votes.

A building permit for Alexander was read and approved. Stormwater applications for Watson and Holter were read and approved. Supervisor Matt Wallin made a motion to sign the stormwater applications for Watson & Holter Kelly VanCise seconded the motion. Motion carried with three votes.

The supervisors would like the secretary to contact West Pa to see what their internet prices are going to be.

The new Lictus propane contract was discussed. Supervisor Jeffrey Carlstrom made a motion to go with option 1 to which is to prepay for 928 gallons at \$2.25 a gallon Supervisor Kelly VanCise seconded the motion. Motion carried with three votes.

Supervisor Matt Wallin made a motion to hire Clyde Hilyer as a temporary worker for \$16.00 an hour and to start when Nate needs him Supervisor Jeffrey Carlstrom seconded the motion. Motion carried with three votes.

Supervisor Kelly VanCise made a motion to pay the bills in the amount \$5,228.26 from the General Fund and \$8,368.00 from the Fire Fund Supervisor Matt Wallin seconded the motion. Motion carried with three votes.

Supervisor Matt Wallin made a motion to adjourn the meeting at 8:08 pm Supervisor Jeffrey Carlstrom seconded the motion. Motion carried with three votes.
