ROAD NEWS:

The road crew will be putting the plow on the grader soon, the rest of the equipment is ready for the winter season.

The supervisors would like a lock to be placed on the water spigot out in front of the garage.

There was some discussion about possibly applying for a dirt & gravel roads project next year for the section of Hultberg Rd from Koebley's to Anderson Rd. to fix the drainage and add some fill to that section. The road crew will look at it this spring.

The wood for the garage is split and ready for winter.

Dyke's garage hasn't found the parts yet for truck 1. The township might need to place the truck on Municibid to get it sold. The secretary will get more information on how to do this. After talking to one of the dealerships that are in the costars program it was recommend that we have specific specs for a pick-up truck. The supervisors and Nate came up with the specs for a pick up and the secretary will get ahold of the dealership and see what she can find out.

The grant that is available right now closes the end of November and cost \$100.00 to apply. This will be a grant to consider for opportunities in the future.

The secretary will check with the president and chief of the Scandia Fire Department about the ATV rally and respond to the Frewsburg Fire Department ATV coordinators.

Chain is needed for the plows. The supervisors and Nate will get quotes for the next meeting.
