The solicitor is looking over the ordinance for the supervisor's wage increase. It was tabled at this time.

There was some discussion on a program that workers compensation is offering due to the township not having light duty to be able to return to work. Supervisor Matt Wallin made a motion to offer this workers compensation light duty program to Jason until he is able to be released to full duty, this will be part time, less than 40 hours but the maximum part time hours doctor will approve and will pay \$10.00 an hour towards this Supervisor Kelly VanCise seconded the motion. Motion carried with three votes.

A building permit was read and approved for R&S Family Trust.

Supervisor Kelly VanCise made a motion to adopt the tax levy resolution 8-2024 Supervisor Matt Wallin seconded the motion. Motion carried with three votes.

The millage rate was read and approved. Supervisor Kelly VanCise made a motion to sign the millage rate paperwork Supervisor Jeffrey Carlstrom seconded the motion. Motion carried with three votes.

Correspondences were read with no action taken.

Supervisor Jeffrey Carlstrom made a motion to pay the bills in the amount \$5,107.51 from the General Fund Supervisor Matt Wallin seconded the motion. Motion carried with three votes.

Supervisor Matt Wallin made a motion to adjourn the meeting at 7:52 pm Supervisor Kelly VanCise seconded the motion. Motion carried with three votes.
