ROAD NEWS:

The road crew has been working on the pot holes and getting ready for oiling. The brake cable was purchased and put on the tractor. Truck 1 is still next in line to go into garage to be fixed. There is a dirt & gravel workshop tour on October 16 at the Conservation District. The supervisors would like the secretary to sign up Mike for the workshop.

Arp Excavating has completed hauling on Reynolds Run Rd. **Supervisor Kelly VanCise made a motion to return their bond Supervisor Matt Wallin seconded the motion. Motion carried with three votes.**

There was some discussion on the oiling. The supervisors would like the road crew to find out what product Freehold Township is using on their roads this year and what the cost per gallon is. **Supervisor Matt Wallin made a motion to purchase subs and drinks for all of the neighboring township employees that are helping with the oiling this year Supervisor Kelly VanCise seconded the motion. Motion carried with three votes.** The road crew and supervisors decided not to oil on August 25 and to do it on August 26 due to man power. **Supervisor Matt Wallin made a motion to hire Stuart Beck at the \$18.00 an hour as a temporary to help with oil if he is off work those days Supervisor Jeffrey Carlstrom seconded the motion. Motion carried with three votes.**

Supervisor Matt Wallin made a motion to pay the bills in the amount \$3,483.38 from the General Fund and \$8,136.61 from the Fire Fund Supervisor Jeffrey Carlstrom seconded the motion. Motion carried with three votes.

Supervisor Jeffrey Carlstrom made a motion to adjourn the meeting at 8:07 pm Kelly VanCise seconded the motion. Motion carried with three votes.
